Baltimore Gas and Electric Company (BG&E) hereby requests Amendments for Operating Licenses DPR-53 and DPR-69 for Calvert Cliffs Units 1 and 2, respectively, with the submittal of the enclosed proposed changes to the Technical Specifications. The FCR shown on the change is for BG&E internal use only.

TECHNICAL SPECIFICATION CHANGE

(FCR 81-1046)

Revise Appendix B, Environmental Technical Specifications Section 3.2 "Radiological Environmental Monitoring" and Section 5.6.2.6, "Nonroutine Radiological Environmental Operating Reports" as shown on the attached pages.

Discussion and Justification

The proposed technical specifications are consistent with the NRC's November 1979 Radiological Assessment Branch Technical Position, Revision 1. The consistency is shown by the elimination of the Radiostrontium analysis of fishbone from the technical specification. Also, a number of TLD's have been added at locations of public interest. The placement of these TLD's will provide extensive coverage of ambient radiation levels.

In addition to the above paragraph, the proposed changes to the technical specifications concludes our commitment to you as stated in the above referenced letter.
