Dear Sir:

Pursuant to Section 50.59 of the Commission's Rules and Regulations, Maine Yankee Atomic Power Company hereby proposes the following modifications to Appendix A of the Operating License.

PROPOSED CHANGE

Reference is made to the Technical Specifications contained in Appendix A to Operating License No. DPR-36 issued to Maine Yankee Atomic Power Company for the Maine Yankee plant. We propose to modify current Technical Specifications as follows:

Replace pages 5.2-2 (Fig. 5.2-1) and 5.2-3 (Fig. 5.2-2) of Specification 5.2 with the attached revised pages 5.2-2 and 5.2-3.

Replace pages 5.3-1, 5.5-1, and 5.12-1 of Specifications 5.3, 5.5 and 5.12 with the attached revised pages 5.3-1, 5.5-1, and 5.12-1.

The attached revised pages include changes submitted via Reference (c) as well as additional changes being proposed via this supplement.

REASON FOR CHANGE

Reference (c) outlined the reasons for establishment of a separate Training Department and an independent Nuclear Safety Engineering Group. This supplement proposes additional organizational changes intended to strengthen management structure, as outlined below.

- 0 The Nuclear Engineering and Licensing department will report directly to a corporate officer. This department shall function as the focal point for Maine Yankee's interface with the Nuclear Regulatory Commission.
- 0 The Manager of Operations will now be a separate position reporting directly to a corporate officer. This position shall be responsible for operational management of the plant and corporate support staff, and for coordination of these activities with other corporate entities.
- 0 The organizational relationships of certain specific plant functions (Fire Protection and Security) have been revised to provide a more efficient management structure.
- 0 Administrative functions will be coordinated through a corporate level office.
- 0 Other changes reflect title changes.

BASIS OF CHANGE

The organizational changes outlined herein, and in Reference (c), provide for more efficient management of the larger staff and more diverse staff activities and responsibilities which have evolved in the past few years.

SAFETY CONSIDERATIONS

This proposed change is not safety related. This change has been reviewed by the Nuclear Safety Audit and Review Committee and the Plant Operation Review Committee.

FEE DETERMINATION

This proposed change is pro forma administrative in nature, and has no safety or environmental significance. For these reasons, Maine Yankee Atomic Power Company proposes this change as a Class II Amendment. A payment of \$1200.00 was enclosed with the original submittal (Reference c) and therefore no additional payment has been included with this supplement.


SCHEDULE OF CHANGE



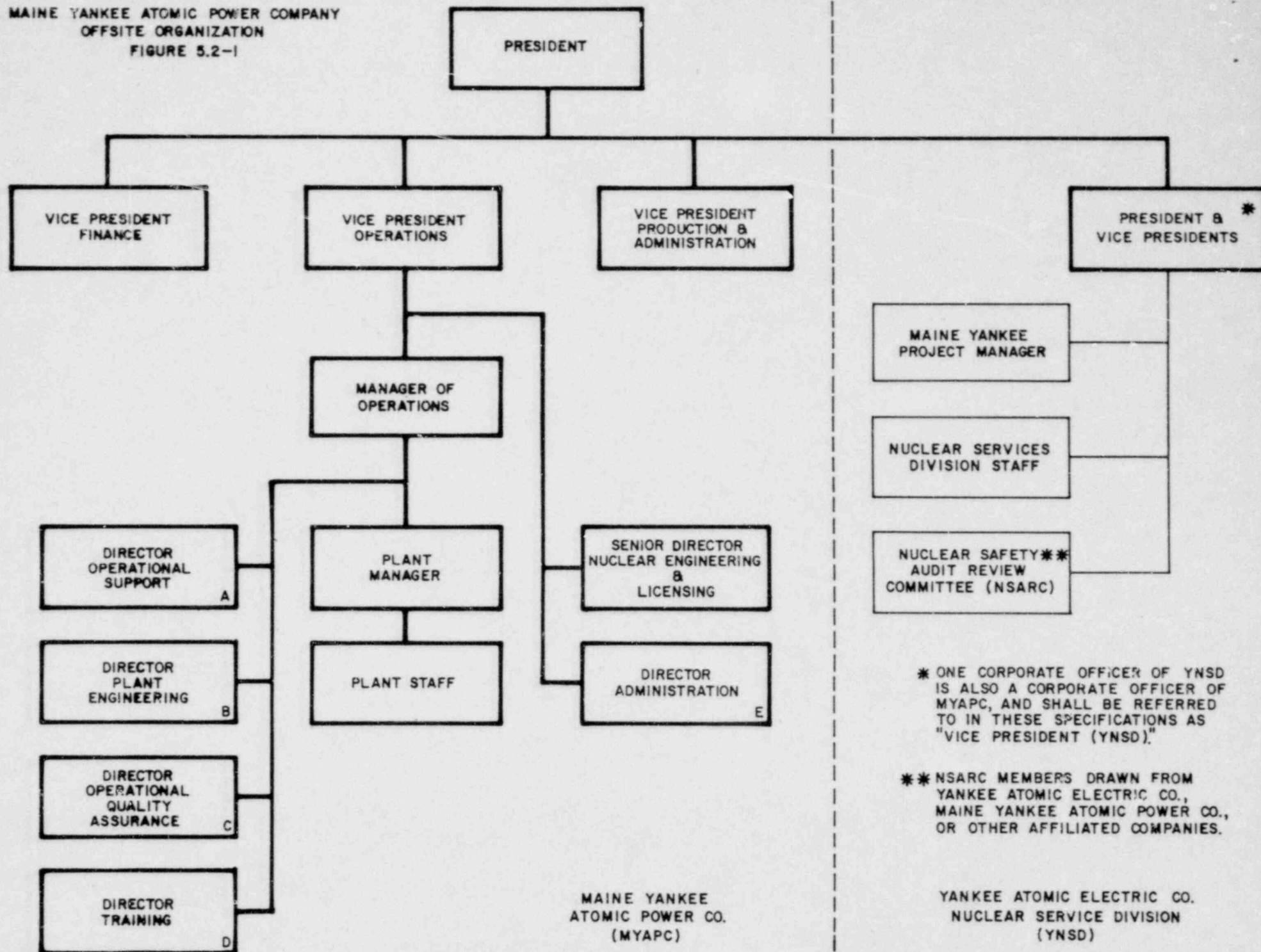
