EVENT DESCRIPTION AND PROBABLE CONSEQUENCES (10)

During surveillance testing the Core Spray Hi Drywell Pressure Switch RV46C tripped in excess of the 2 psi Tech Spec limit in table 3.1.1. Item D2. The as found trip point was 2.3 psi. Safety significance is considered minimal since the RV46 switch would have tripped slightly (.3 psi) above tech spec limit. The Core Spray System would have performed its intended function since only one logic channel redundancy was compromised.

CAUSE DESCRIPTION AND CORRECTIVE ACTIONS (27)

The cause of the occurrence was attributed to sensor repeatability. The sensor would have operated within design accuracy but slightly above Tech. Spec. limits. The sensor was recalibrated within the limit of two psi. It is planned to replace these sensors with a qualified sensor of improved accuracy during a future refueling outage.
