LETTER TO MR. JAMES H. TAYLOR FROM OLAN D. PARR,
DATED JUNE 14, 1977

The subject letter approved the withholding of proprietary material from public disclosure. We would like to clarify the first paragraph of that letter. The paragraph should read:

"By your letter, dated May 19, 1977, you provided additional justification for withholding as proprietary certain material submitted with Amendments 7, 10, 11 and 13 to BSAR-205. In that letter you advised that after recently reviewing Amendment No. 7, a portion of the response to NRC request 221.61 could be reclassified as non-proprietary. The portion to be reclassified will be resubmitted with Amendment No. 15 on December 15, 1976 as non-proprietary. The remainder of Amendment No. 7 would remain proprietary in your view."

If you do not agree with this clarification, please advise.
