Gentlemen:

This refers to the QA program inspection conducted by Mr. R. E. Oller of this office on September 28-October 2, 1981, of your facility at Davenport, Iowa, associated with the manufacture of timers and counters and to the discussions of our findings with you and members of your staff at the conclusion of the inspection.

This inspection was made to confirm that, in the areas inspected, your QA program is being effectively implemented. The inspection effort is not designed to assure that unique quality requirements imposed by a customer are being achieved; nor to assure that a specific product, component, or service provided by you to your customers is of acceptable quality. As you know, the NRC requires each of its licensees to assume full responsibility for the quality of specific products, components, or services procured from others. You should, therefore, not conclude that the NRC's inspection exempts you from inspections by an NRC licensee or his agents, nor from taking effective corrective action in response to their findings.

Areas examined and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

You will note that the three items in the Notice of Nonconformance are related to management's failure to assure compliance with committed actions concerning the findings identified in Inspection Report No. 80-01. Consequently, please inform us of the steps you have taken or plan to take, to assure that management's commitments will be accomplished and implemented.

Please provide us within 30 days from the date of this letter a written statement containing: (1) a description of steps that have been or will be taken to correct these items; (2) a description of steps that have been or will be taken to prevent recurrence; and (3) the date your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for good cause shown.

If we do not hear from you in this regard within the specified periods noted above, the report will be placed in the Public Document Room.
