This refers to the routine safeguards inspection conducted by Mr. D. W. Jones of this office on November 16-20 and November 30 - December 4, 1981, of activities authorized by NRC License No. SNM-1097 at Wilmington Manufacturing Department facility and to the discussions of our findings held with Mr. W. J. Hendry, Regulatory Compliance Manager, at the conclusion of the inspection.

Areas examined during this inspection included your program for nuclear material control and accountability under the applicable provisions of Title 10, Code of Federal Regulations, Part 70, "Special Nuclear Material," and specific license conditions. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspector.

Within the scope of this inspection, no violations or deviations were disclosed.

We have examined actions you have taken with regard to previously identified enforcement matters and unresolved items. These are discussed in the enclosed inspection report.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, activities involving safeguards and security measures are exempt from public disclosure; therefore, the enclosed report with the exception of the cover page, which is an inspection summary, will not be placed in the Public Document Room.
