SUBJECT: MEETING SUMMARY

On December 2, 1981 at 7:00 p.m. the NRC staff held a public meeting in Seabrook, New Hampshire. Its purpose was to provide the public with an opportunity for direct access to the staff to express environmental concerns relevant to the reviews being conducted in preparation for issuance of the OL-DES. The public meeting in town was timed to follow the environmental site visit which had been concluded earlier the same day. Enclosure 1 is the meeting agenda.

Initial coordination was established through a telephone call by the Project Manager, followed by a letter from the Assistant Director for Licensing, to the Seabrook Selectman's office (Enclosure 2). Advance publicity was made through a press release issued by the NRC Region I Office of Public Affairs (Enclosure 3). A transcription service and the use of a locally provided public address system were funded by the NRC.

Although the publicized intent of the meeting was to hear environmental concerns to ensure the staff had an accurate assessment of the scope of the review, it was recognized that other issues (specifically emergency preparedness and evacuation) considered important by local residents might be raised. To reinforce the staff's ability to address these matters, Mr. Robert Bores from Region I attended to discuss the review process and status of these issues to the limited extent possible at this early stage in the OL proceedings.

Approximately 90 people attended the meeting. These included members of some of the organizations who have filed petitions for leave to intervene, utility employees, the NRC Senior Resident Inspector, and representatives from the local news media and the Associated Press. The meeting was moderated by Mr. Steven Coes, Administrative Assistant for the Town of Seabrook. Mr. Coes established a sign-up list for persons wishing to address the panel of staff members. Opportunities to speak were provided to those people on the list by the order in which the names appeared. A transcript of the proceedings is attached as Enclosure 4. All persons present and whose names appeared on the sign-up list had an opportunity to discuss their concerns with the staff. More than one opportunity to speak was provided to all who requested it.
