This preliminary notification constitutes EARLY notice of events of POSSIBLE safety or public interest significance. The information presented is as initially received without verification or evaluation and is basically all that is known by IE staff on this date.

Facility: Union Carbide Corporation Medical Products Division Tuxedo, New York (DN 70-687)

Subject: SOUTH CAROLINA SUSPENDS LICENSEE SHIPMENTS OF RADIOACTIVE WASTE FOR BURIAL

On July 13, 1981 the State of South Carolina imposed a suspension, of not less than 30 days, on the transportation of radioactive waste material into the State of South Carolina for burial at the Barnwell low level waste burial site by the licensee. The licensee was also assessed a civil penalty of \$3,500 by the State of South Carolina.

These actions were taken by the State of South Carolina after a wooden crate in a shipment, which arrived at the burial site on June 29, 1981 was found with an open seam. Contaminated solid material had been released onto the floor of the truck, and thus the crate was no longer a strong, tight container. Radiation levels on the under surface of the vehicle were found to be in excess of 200 mR/hr (280 mR/hr was measured). The wooden crate, containing approximately 167 millicuries of mixed fission products of waste material, was repaired by personnel at the burial site and was buried.

The licensee was informed of this incident by Barnwell on July 1, 1981 and by the State of South Carolina on July 13, 1981. Licensee management is meeting with the State of South Carolina today (July 16, 1981) in Columbia, South Carolina to discuss long term corrective actions.

Media interest is expected because the states with burial grounds publicize such state enforcement actions. A press release is not planned by the licensee nor NRC at this time.

This PN is issued for information only. This incident will be reviewed by Region I. The State of New York has been notified.

Region I received notification of the occurrence by telephone from Region II at 3:30 p.m. on July 15, 1981 and is current as of 4:15 p.m. on July 15, 1981.
