This refers to the inspection activities performed by our Senior Resident Inspector, Mr. A. B. Beach of our staff, during the period November and December 1981, of activities authorized by NRC Construction Permit CPPR-145 for River Bend, Unit 1, and to the discussion of our findings with Mr. Philip D.
