Dear Mr. Greenberg:

Puget Sound Power & Light Company, Pacific Power and Light Company, The Washington Water Power Company, and Portland General Electric Company filed an amended application for licenses to construct and operate the Skagit/Hanford Nuclear Project, Units 1 and 2. The proposed facilities will consist of boiling water reactors with a rated core thermal power of 3800 megawatts and a net electrical output of approximately 1300 megawatts per unit.

The site for these reactors is located approximately eight miles west of the Columbia River, seven miles north of the Yakima River at Horn Rapids Dam, and twelve miles northwest of the city of North Richland in Benton County, Washington.

We expect to schedule our review of this application so that decisions can be made by an Atomic Safety and Licensing Board by mid-1983 as to whether construction permits should be issued.

For further details concerning the application, I am enclosing a copy of a related notice which has been forwarded to the Office of the Federal Register for publication.
