Gentlemen:

This refers to the inspection conducted by Messrs. J. R. Boardman and M. E. Murphy of our staff during the period December 14-17, 1981, of activities authorized by NRC Facility Operating Licenses DPR-51 and NPF-6 for the Arkansas Nuclear One, Units 1 and 2, and to the discussions of the findings by the inspectors with members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

During this inspection, it was found that certain of your activities were not conducted in full compliance with NRC requirements. Consequently, you are required to respond to this matter, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your responses should be based on the specifics contained in the Notice of Violation enclosed with this letter.

Two new unresolved items are discussed in paragraphs 4 and 7 of the enclosed report.

We have also examined actions you have taken with regard to previous inspection findings. The status of these items is identified in paragraphs 2 and 5 of the enclosed report.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
