You responded to our request by letter dated January 29, 1982. In your response, you identified two references, p and z which you were not sending to FRC due to their proprietary nature. You indicated that these items were available for audit by NRC or FRC staff at your corporate offices.

It is our request that you send references p and z, or copies thereof, to the NRC staff for review, "Attention: Zoltan R. Rosztoczy, Chief, Equipment Qualification Branch" by the most expeditious method available. As discussed with members of your staff, the transmittal letter should include the proprietary claim for the documents (which should be stamped as proprietary) and a statement of your plan for completion of the remaining applicable sections of 10 CFR 2.790. Upon receipt, these documents will be treated as proprietary. Questions regarding this request can be directed to your project manager or to Mr. Ed Shomaker, staff attorney at (301) 492-8653.

We have also determined that we will need the additional information identified in the enclosure to this letter to continue our review of those equipments relating to TMI Action Plan Items. ## Information Requested

- Reference 5 does not provide adequate detail with respect to identification of TMI Action Plan equipment installed.
  - a. Identification of all TMI Action Plan equipment installed as of 1/1/81 was provided in Reference 2.
  - b. Identification of TMI Action Plan equipment installed with implementation dates after 1/1/81 is requested.
  - c. The approximate installation date for the TMI Action Plan equipment items is requested so that the appropriate qualification criteria (NUREG-0588 or DOR Guidelines) can be used in the EEQ evaluation.
- 2. Where the Licensee has a standard Owners' Group position with respect to a NUREG-0737 technical area or has requested extensions of implementation dates, this information is requested in order to incorporate it into the review.
