EMERCENCY TELEPHONE ROSTER

1.0 POLICY

It is the policy of West Valley Nuclear Services to provide a list with outside agencies phone numbers and delineate responsibilities for making notification to outside agencies in case of emergencies.

2.0 SCOPE

2.1 Purpose:

This procedure provides the phone numbers of personnel and outside agencies involved with emergency response that may be called by the Liaison Manager and the DOE-ID WCC Communicator.

2.2 Discussion:

Upon implementation of the Emergency Plan, the Liaison Manager, and the DOE+ID WCC Communicator will make required notifications using the appendices of this Emergency Telephone Roster.

3.0 DEFINITIONS

4.0 RESPONSIBILITIES

- 4.1 The Liaison Manager has the responsibility to notify outside agencies as per Emergency Implementing Procedure G-7.
- 4.2 The DOE-ID WCC Communicator has the responsibility to notify the Warning Communication Center (WCC) in Idaho and maintain an open line of communication at all times during the emergency as per Emergency Implementing Procedure G-36.
- 4.3 The Liaison Manager and the DOE-ID WCC Communicator shall maintain a record of all communications with off-site personnel and organizations.
- 4.4 The Emergency Planning and Preparedness Coordinator shall be responsible for quarterly verification and updating of the Emergency Telephone Roster.

- 6.1 Appendix A is the Liaison Manager Call List. The Liaison Manager shall activate the off-site emergency response agencies as per Emergency Implementing Procedul G-7.
- 6.2 Appendix ontains phone numbers of the Westinghouse Energy and Utility Systems Emergency Committee that may be useful during an emergency.
- 6.3 Appendix C contains phone numbers that may be useful for medical emergencies.
- 6.4 Appendix D contains phone numbers that may be useful for fire and/or safeguards emergencies.
- 6.5 Appendix E contains phone numbers that may be useful during any emergency.
- 6.6 Changes to the appendices shall be approved by DOE and the WVNS President.
