Enforcement Conference Summary

On May 3, 1990, the attendees listed in Enclosure 1 met at the University of Puerto Rico to discuss the findings of the NRC inspection conducted on April 2-3, 1990, and the licensee's proposed corrective action.

The NRC representatives discussed NRC concerns, particularly the failure of the licensee's Radiation Safety Officer to effectively implement the Radiation Safety Program and the failure of University administration to maintain management oversight of the program. NRC representatives also discussed the purpose of the enforcement conference and explained the NRC Enforcement Policy. Licensee representatives discussed in detail corrective actions taken and proposed to prevent a recurrence of the violations. The licensee committed to increased management attention to its Radiation Safety Program.

NRC representatives concluded the meeting by stating that a final decision would be made as to the nature of escalated enforcement action in the near future.
