This is in response to your letter of May 7, 1990, in which you indicated concern about the NRC staff agreement to stay the effective date of two proposed amendments to the Shoreham license. If granted, these proposed license amendments would allow LILCO to disband its Local Offsite Emergency Organization and reduce the size of the Shoreham security force. Both actions would reduce LILCO's economic burden of complying with the terms of its full-power license for Shoreham.

As I explained to Mr. James McGranery in a letter dated May 7, 1990, I did agree that the effectiveness of any staff action with respect to these two license amendments would be stayed until May 15, 1990. The agreement was based on the progress of the staff's review effort. Although May 15, 1990, has passed, the staff has not yet completed its review to allow issuance of the amendments. Please be assured that our plan is to promptly issue these license amendments upon completion of our reviews, assuming favorable findings.
