- i) All reports and opinions on the accident of recirculation pump of Fukushima Daini(1) Nuclear Power Plant Unit No.1 in 1984, which Byron-Jackson Co. has presented to NRC.
- i) All materials showing the cause and countermeasure of the accident of recirculation pump of Fukushima Daini(1) Nuclear Power Plant Unit No.1 in 1984, which MITI(Ministry of International Trade and Industry) or TEPCO(Tokyo Electric Power Co.) has presented to NRC.
- i) All materials on automatic shutdown of Fukushima Daini(i) Nuclear Pover Plant Unit No.3 on December 3 1988.
- All materials on the accident of recirculation pump of Fukushima Daini(I) Nuclear Power Plant Unit No.3 on January 1989, which MITI (Ministry of International Trade and Industry)or TEPCO(Tokyo Electric Power Co.) has presented to NRC since April 1989.
- 1) All the detailed explanations on "Exciting Force" which is described in the report of Byron-Jackson Co. (cf. "Information on Recirculation Pumps", Appendix B-13 of FOIA-89-143).
- n) All the detailed explanations on "frequency in water" and "natural frequency" which are described in the report of Byron-Jackson Co. (cf. "Information on Recirculation Pumps", Appendix B-13 of FOIA-89-143).
- i) All materials showing the cause and countermeasure of the accident in which the broken metal pieces travelled into the reactor.
- i) NRC's opinion about the accident of recirculation pump of Fukushima Daini(1) Nuclear Power Plant Unit No.3 on January 1989.

If you determine that all or a part of the information on my request can be disclosed, please send me that one by airmail as soon as possible.

If any expenses in excess of \$50 are incurred in connection with this request, please inform me in advance for my approval. And I ask that any fees be waived because furnishing information could be considered as "primarily benefitting the public".

If you determine that some portion of the information on my request are exempt from release, I request that you provide me with remainder, I hereby reserves my right to appeal any such decisions.
