Gentlemen:

This refers to the routine, unannounced radiation safety inspection conducted by Mr. Wesley Holley of this office on May 9, 29, and 30, 1990, of well logging activities at the Ladder Companies, Inc., Reed-19-1 well site, Section 19 4N4E, Pontotoc County near Stratford, Oklahoma. Records of other activities were reviewed at your district office in Hominy, Oklahoma. The inspector reviewed activities authorized by NRC Byproduct Material License No. 15-21332-01, and a discussion of our findings was held by the inspector with members of your staff at the conclusion of the inspection.

The inspection was an examination of the activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observations by the inspector.

The inspector determined that your Hominy, Oklahoma, district manager was the logging supervisor for all logging activities and performed all activities utilizing radioactive material. The inspector noted that logging equipment appeared to be in adequate condition and observed the loading of the neutron source into the logging tool with source handling tools. The inspector observed the written communications between your corporate radiation safety officer (RSO) and the district manager appeared to be effective in communicating program requirements and directing resolution of problems.

During this inspection, certain of your activities were found not to be conducted in full compliance with NRC requirements. A three-part violation was identified during the inspection at the temporary jobsite near Stratford, Oklahoma. Consequently, you are required to respond to this matter in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.
