SUBJECT: ISSUANCE OF AMENDMENT (TAC NO. M86065)

The Commission has issued the enclosed Amendment No. 157 to Facility Operating License No. DPR-61 for the Haddam Neck Plant, in response to your application dated March 22, 1993.

The amendment will change the following:

The footnote to Technical Specification 3.8.3.2.b is being revised to identify the available options for providing power to the 480 volt buses during plant shutdown (mode 5 or mode 6). This change adds the bus tie breakers 6Tll and 11T6 to the list of available tie breakers.

The change to Special Test Exception Technical Specifications 3.10.3 and Bases Section 3/4.10.3, Position Indication System-Shutdown, addresses exceptions for operability of the individual rod position indication (IRPI) system during shutdown modes.

A change to Bases Section 3/4.4.4., Relief Valves, clarifies why it is acceptable to place the power-operated relief valve (PORV) autotrip signal in the bypass position if a pressurizer pressure channel fails.

A change to Bases Section 3/4.7.3, Service Water System, clarifies the definition of the service water header and describes the Adams filter bypass line and valves that were recently added to the service water system.
