SUBJECT: REVIEW OF SECURITY PLAN SUBMITTAL

This acknowledges receipt of your letter dated March 29, 1993, which transmitted changes identified as Revision 29A to the Prairie Island Security Plan submitted under the provisions of 10 CFR 50.54(p).

We have reviewed the submitted changes and have determined that they are consistent with the provisions of 10 CFR 50.54(p) and are therefore acceptable, except as noted in the enclosure of this letter. For those items identified as being unacceptable under the criteria of 10 CFR 50.54(p), the previously approved plan revision must be followed.

You are requested to provide corrections to your security plan to address the issues identified in the enclosure within two months after receipt of this letter. You may submit the changes either in accordance with 10 CFR 50.54(p) or 10 CFR 50.90.
