PROTECTIVE MEASURES TECHNICAL WORKSHOP (SP-90-119)

You are invited to attend a Protective Measures Technical Workshop to be held on September 26-27, 1990, in Baltimore, Maryland at the O'Connor State Office Building. The workshop is designed to provide a detailed understanding of the technical tools used for assessment of protective measures issues. The workshop will begin at 9:00 a.m. on September 26 and end at 5:00 p.m. on September 27.

Upon completion of the workshop, the student will have the ability to use and teach others the use of the technical tools involved in classification, core damage, source term, dose consequence and protective measures assessment. The workshop will involve considerable hands-on application of paper procedures and an introduction to the computer based assessment tools (i.e., RASCAL Code). These procedures are used by the NRC response organization during the assessment of severe reactor accidents and to a lesser extent for other accidents.

NRC 111 fund travel and per diem for two individuals from each State to attend the workshop. We suggest each State make the decision as to which individuals should attend. The workshop is designed for response personnel with technical responsibilities in protective measures assessment.
