Technical Specification Change Request (TSCR) No. 70

The Licensee requests that the attached changed pages of the Appendix A Technical Specifications (Tech. Specs.) (i.e., 3.9-2, 3.9-3, and B3/4 9-1) replace the corresponding pages in the Appendix A Tech. Specs.

Description of Change

Reference to the Appendix B Tech. Specs. is being replaced by reference to the ODCM.

Reason for Change

License Amendment 43 to the TMI-2 Operating License relocated the Limiting Conditions for Operation (LCOs) of the Appendix B Environmental Technical Specifications to the Offsite Dose Calculation Manual (ODCM). Reference to these LCOs in Appendix A Technical Specification section 3.9.12, "Fuel Handling Building/Auxiliary Building Air Cleanup Systems," should have been changed to reference the ODCM; however, this section was inadvertently left as is. This TSCR proposes to resolve that administrative error by properly referencing the ODCM.

Justification of Change

This change is administrative in nature; it makes the Appendix A Tech. Specs. consistent with License Amendment 43.

No Significant Hazards Consideration

10 CFR 50.92 provides the criteria which the Commission uses to evaluate a No Significant Hazards Consideration. 10 CFR 50.92 states that an amendment to a facility license involves No Significant Hazards if operation of the facility in accordance with the proposed amendment would not:

- Involve a significant increase in the probability or consequences of an accident previously evaluated, or
- Create the possibility of a new or different kind of accident from any accident previously evaluated, or

Involve a significant reduction in a margin of safety.

This change would not involve a significant increase in the probability or consequences of an accident nor create the possibility of a new or different kind of accident because the change is administrative in nature and makes the Appendix A Tech. Specs. consistent with License Amendment 43. This change would not involve a significant reduction of the margin of safety since it corrects an administrative omission in a prior License Amendment.

Therefore, the proposed changes involve no significant hazards considerations as defined by 10 CFR 50.92.

Implementation

It is requested that the amendment authorizing this change become effective immediately upon issuance.
