AEC License 34-7225-1 has an expiration date of October 31, 1960, as noted in your letter of August 25, 1960.

In reviewing the licensed uses under this number, we find that the only condition not covered by our License No. 34-7225-9, is the provision permitting use and storage of sealed cobalt sources at customer's facilities as delineated in conditions 11, and 13 as amended September 13, 1960.

To reduce the paperwork required by ourselves and the USAEC, we would like to propose that License No. 34-7225-1 be allowed to expire, that we're permitted to transfer the active material investory to our License No. 34-7225-9, and that License No. 34-7225-9 be amended to permit use of sealed cobalt sources at customer's facilities. This seems advisable at this time as we are currently preparing an application for a broad license, which should be forwarded to you within a few weeks.

To implement the immediate changes required in our Licensed activities we are:

1. Submitting the completed form "Certification of Status of Radioisotope (Byproduct Material) Program under United States Atomic Energy Commission License Number 34-7225-1.

2. Hereby requesting amendment of License No. 34-7225-9 to the effect that, "Notwithstanding the provisions of Condition 11 of 34-7225-9, sealed sources of cobalt-60 may be stored in, loaded into, or unloaded from Picker teletherapy units, radiography units and shipping containers at customer's facilities, such use or storage to be under the direct supervision of D. T. Green, E. Slagle, J. Snarr. E. W. Coleman, N. Bender, or R. W. Arndt."
