Dear Mr. Johnson:

On July 17, 1991, you wrote to Sandra Wastler of my staff concerning the role of the Fish and Wildlife Service in reviewing the environmental activities related to the licensing by the Nuclear Regulatory Commission of Envirocare of Utah's proposed lle.(2) byproduct material disposal facility at Clive, Utah. At that time, you furnished the following list of species which may be present in the concerned area:

Listed

bald eagle peregrine falcon

Haliaeetus leucocephalus Falco peregrinus

Section 7(c) of the Endangered Species Act of 1973, as amended, requires a biological assessment to determine the effects of the proposal on listed and proposed species. The Draft Environmental Impact Statement (DEIS), copy enclosed, published for comment by NRC on February 26, 1993, discusses endangered and threatened species in Section 4.5.4. No threatened or endangered plant or animal species are known to occur in the vicinity of the Clive site. Based on the assessment in the DEIS, we do not believe that construction and operation of the proposed facility will have an impact on any listed or proposed species or on critical or proposed critical habitat.

We would appreciate an update on any changes that may have occurred in the list of endangered species provided to us in your earlier letter.
