Revision Number 1 to the ANO Fire Hazards Analysis

Gentlemen:

In accordance with 10CFR50.71(e) and 10 CFR50.4(b)(6), 10 copies of Revision Number 1 of Arkansas Nuclear One's (ANO) Fire Hazards Analysis (FHA) are enclosed (Controlled Copy Nos. 1-10). Controlled Copy No. 11 is being forwarded to Region IV.

Generic Letter 86-10, "Implementation of Fire Protection Requirements," Section F, requested licensees to incorporate, into the Final Safety Analysis Report, the fire prote tion program that has been approved by the NRC including the FHA and major commitments that form the basis for the fire protection program. ANO revised its ANO-1 and ANO-2 Safety Analysis Reports (SARs) to include the fire protection program in Amendment 9A, dated October 25, 1991 (0CAN109114). The FHA was incorporated by reference into Appendix 9B of the SARs, as permitted by Generic Letter 86-10. Entergy Operations has determined, through a subsequent review of Section F and Item 8 of Enclosure 1 to Generic Letter 86-10, that it is the NRC's intent that the FHA be submitted to the NRC. Therefore, Revision Number 1 of the FHA is enclosed. This revision of the FHA contains changes implemented since the issuance of Revision 0 (the original version of the FHA prepared concurrently with ANO-1 and ANO-2 SAR Amendment 9A).

As required by 10CFR50.71(e)(2), I h. eby certify that to the best of my knowledge and belief, the information contained in Revision Number 1 to the ANO FHA is accurate. Since this is the first transmittal of the FHA to the NRC, binders containing the entire document are enclosed.
