CHAIRMAN SELIN: Good morning. We have an affirmation session this morning with one item. Mr. Chilk, would you lead us through.

SECRETARY CHILK: Yes. The item, Mr. Chairman, is SECY-93-187, Georgia Power Company - Partial Director's Decision under 10 CFR 2.206. The Commission here is being asked to act on an Order in response to the NRC staff's partial decision under 10 CFR 2.206 and Director's Decision 93-08. The staff's partial decision responds to a petition filed by Allen Mosbaugh and Marvin B. Hobby in September 1990, and supplemented in October 1990, and July 1991, which asked for initiation of proceedings and other enforcement action against Georgia Power Company.

The Chairman and Commissioners Rogers and Remick have approved the Order that vacates the staff's partial decision, and remands the matters decided therein to the staff for further consideration. Commissioner de Planque is on travel and did not participate. Would you please affirm your votes.

(Chorus of ayes.)

MR. CHILK: I have nothing further.

CHAIRMAN SELIN: Why don't you change it to the Director's Partial Decision since, to the best of my knowledge, we have an entire Director of NRR?

(Laughter.)
