Whereas the indirect billing rates used in the contract were: Fringe - 32% Overhead - 80% G&A - 11% Whereas the final, audited rates for FY 1977 are: Fringe - 31.63% Overhead - 76.37% G&A - 10.42% Therefore, the contract is modified to incorporate the above approved final indirect rates. 2. This modification also deobligates the unliquidated balance of \$1,678 remaining in the contract. As a result of this modification, ARTICLE XVIII, paragraphs a and b are changed as follows: ARTICLE XVIII - OBLIGATION OF FUNDS, ESTIMATED COST AND FIXED FEE a.
