

Areas examined during this inspection are described in the Nuclear Regulatory Commission Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the items of noncompliance brought to your attention in the enclosure to our letters dated April 29, 1981 and July 17, 1981. We have no further questions regarding your action at this time.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements as set forth in the Notice of Violation, enclosed herewith as Appendices A and B. These violations have been categorized into the levels described in the Federal Register Notice (45 FR 66754) dated October 7, 1980. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendices A and B. In addition to the need for corrective action regarding these specific violations, we are concerned about the implementation of your management control systems as it relates to your surveillance test program. Consequently, in your reply, you should describe in particular, those actions taken or planned to improve the effectiveness of your surveillance test program.

Each person who produces, receives or acquires Safeguards Information is required to ensure that it is protected against unauthorized disclosure. Therefore, Appendix B, the pertinent section of the enclosed inspection report, and your response to Appendix B will not be placed in the Public Document Room and will receive limited distribution pursuant to 10 CFR 73.21(c).

The responses directed by this letter and the accompanying Notices are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.


