Dear Mr. Eddleman:

At the public meeting on April 7, 1982, you requested that copies of documents regarding the Diablo Canyon Design Verification Program be made available to "other petitioners to intervene." (Tr. 75). The Staff agreed to send these documents to the Shearon Harris local public document room (LPDR). This is to confirm that on April 21, 1982, the Local Public Document Room (LPDR) Branch sent to the LPDR in Raleigh the following documents (See attached memorandum):

- Commission "Order Suspending License," CLI-81-30, November 19, 1981.
- 2) Letter dated November 19, 1981 from Harold Denton, Director, Office of Nuclear Reactor Regulation ("NRR") to M. H. Furbush, Pacific Gas & Electric Company ("PG&E"), entitled "Diablo Canyon Unit 1 -Independent Design Verification Programs."
- 3) Letter dated December 4, 1981 from M. H. Furbush (PG&E) to Harold R. Denton (NRR), transmitting detailed program plan for independent seismic design verification.
- 4) "SECY Paper" (SECY-82-29), transmitting NRC Staff evaluation of Diablo Canyon proposed seismic design verification program, March 1, 1982.
- 5) Letter dated March 30, 1982 from PG&E to Harold R. Denton (NRR) and R. H. Engelken, Regional Administrator (Region V), entitled "Design Verification Program, Tenth Semi-Monthly Status Report for March 11, 1982 through March 24, 1982."

6) Letter dated April 2, 1982 from Teledyne Engineering Services to PG&E, Harold R. Denton (NRR) and R. H. Engelken (Region V), transmitting "Diablo Canyon Nuclear Power Plant Independent Design Verification Program (IDVP) Phase I Program Management Plan," March 29, 1982.

At the meeting, you referred to "the List of 100 Mistakes that were discovered in the operating license stage just before or after the review process had supposedly been completed." (Tr. 72). That list is contained in the document designated Item 5 above, the Tenth Semi-Monthly Status Report, Attachment 1, "Status of RCLA EDIS."

I understand that after that meeting you contacted the LPDR Branch and requested a copy of another Diablo Canyon document. Although the LPDR Branch also agreed to transmit that document to you, the LPDR Branch has not been able to identify it. based on the information you provided and will contact you to obtain a more detailed description of the document.

As you may be aware, local public document rooms are established and maintained to make available to the public documents related to the particular facility for which the LPDR is established (along with documents of general interest such as the NRC Rules and Regulations). Documents relating to other facilities are not customarily sent to a particular LPDR. Thus, the Shearon Harris LPDR does not customarily receive and maintain copies of documents relating to other facilities. However, in order to accommodate you and other members of the public at the meeting on April 7, 1982, the Staff agreed to send certain documents relating to Diablo Canyon to the Shearon Harris LPDR.

You should direct any further requests for publicly available documents related to other facilities to the NRC Washington Public Document Room (PDR). Such documents may be obtained from the PDR at a nominal charge. Pursuant to the Freedom of Information Act ("FOIA"), you may request access to NRC documents not previously made available to the public. (However, certain documents are exempt from disclosure under one or more of the exemptions specified in the FOIA or in NRC regulations in 10 C.F.R. Part 9.) See "Citizen's Guide to U.S. Nuclear Regulatory Commission Information" and "Public Document Room Users Guide," both of which have been previously transmitted to you.

In your "Response to Applicant's Motion re Scheduling," March 24, 1982, you requested a copy of "a new edition of Chapter 10 of the Code of Federal Regulations..." (Response, at 2). I understand that a loose-leaf set of the NRC Regulations in 10 C.F.R. (as revised monthly) is available in the LPDR in Raleigh. In addition, at the request of the Atomic Safety and Licensing Board Chairman, the LPDR Branch sent a copy of the latest paper bound edition of 10 C.F.R. (revised as of January 1, 1981) to the Chapel Hill library. It is my understanding that a new edition of the paper-bound

edition of 10 C.F.R. (revised as of January 1, 1982) will be issued in late May. In your Response, you also requested a copy of "a list of all documents heretofore filed in the Harris plant dockets 50-400 and 50-401, if such exists in NRC's filing system." (Response, at 2). According to the Chief of the LPDR Branch, the LPDR in Raleigh has "accession lists" which consist of old "chron sheets" from Central Files through mid-1980. These "chron sheets" contain entries for documents filed in Shearon Harris as such documents were received by Central Files. In addition, the LPDR has weekly computer print outs of Shearon Harris documents filed from 1979 forward. I understand that the LPDR Branch is making arrangements to send to the LPDR a computer print-out of documents filed from 1979 onward, which lists Shearon Harris documents by category rather than on a weekly basis.
