Dear Mr. Palladino;

I am forwarding a copy of a petition which represents the position of citizens from various communities on Long Island. None of us, to my knowledge, are members of any organized, opponents groups but represent the general citizenry of Suffolk and Nassau Counties.

What we share is a love for, or environment and safety of our families. There is grave concern about the necessity of evacuation of Long Island in the event of a nuclear "incident" at Shoreham Nuclear Power Plant. At the widest Long Island is 25 miles. People from the eastern end, particularly the north fork, must go toward the contaminated area in order to evacuate.

I beseech you, as Chairman of the N.R.C., to carefully evaluate the safety of the plant and possible evacuation plans before granting an interim license or any license at all.

Dear Congressman Carney:

We understand there is a congressional bill in committee which would grant Shoreham Nuclear Power Plant an interim license before completing the Nuclear Regulatory Commission hearings. By granting this interim license it appears the assumption is made that the plant will pass the safety inspection recently called for by the Suffolk County Legislature. Early fueling prevents the thorough inspection of that contaminated area.

It is our opinion that the Shoreham Nuclear Power Plant is a twelve year old mistake which has now become an ominous reality for all of us. Before the plant is allowed to fuel, an independent inspection should be completed and a sane, workable emergency evacuation plan be accepted by our citizens.

As constituents we ask you to represent our views on this matter.
