This letter refers to a routine safeguards inspection of your activities at San Onofre Nuclear Generating Station, Unit 2, authorized under NRC License No. NPF-10 conducted by Mr. D. W. Schaefer of this office on April 4, 1982 through April 8, 1982. It also refers to the discussion of the inspection findings held by the inspector with Mr. W. C. Moody, Deputy Station Manager, members of his staff, and other SCE representatives on April 8, 1982.

The inspection included examination of activities related to your program for protection against radiological sabotage and against theft of special nuclear material in accordance with applicable requirements of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials," your Security Plan, and license conditions pertaining to physical protection as described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and records, interviews with facility and contract personnel, and observations by the inspector.

Within the scope of this inspection, no items of noncompliance were observed.
