## PROCEEDINGS

CHAIRMAN PALLADINO: The meeting will please come to order. This is an affirmation/discussion session. Will the Secretary please walk us through the items on the agenda?

MR. CHILK: The first item is SECY-82-140, an FOIA appeal 82-A-2C -- Devine -- regarding the investigative jurisdiction of IE and OIA where the Commission is being asked to respond to an FOIA Appeal to release certain documents related to the Investigative Jurisdiction of IE and UIA.

All Commissioners have approved a response that releases two documents, withholds another one in part, and withholds in their entirety four other documents.

Would you please affirm your votes? (Chorus of ayes.)

MR. CHILK: The second item, Mr. Chairman, is SECY-82-152, Diablo Canyon, Closing of Newmark Inquiry, and this did not appear on our schedule. I, of course, need a short notice vote.

MR. CHILK: Here the Commission is being asked to approve an order publicly announcing the conclusions of the Newmark inquiry.

All Commissioners have voted to approve the order.

Commissioner Roberts requested the transcript from the

Commission meeting on this subject be released to the public.

This will be handled separately.

May I ask that you please affirm your votes on the approval of the order?

(Chorus of ayes.) MR. CHILK: That concludes the affirmation session. CHAIRMAN PALLADINO: Is there anything further to come before the Commission at this time? (No response.) CHAIRMAN PALLADINO: We are adjourned. [Whereupon, the meeting was adjourned at 2:15 o'clock p.m., to reconvene at the Call of the Chair.]
