EVENT DESCRIPTION AND PROBABLE CONSEQUENCES (10)

02 During normal operation while performing surveillance testing, HPCI steam supply pressure switch PS-2246A was found to have a setpoint of 110 psig. PS-2246A initiates the isolation of HPCI when steam pressure drops below that required to adequately drive the HPCI turbine. Tech. Spec. Table 3.2.B specifies a setpoint of 50 to 100 psig for PS-2246A. Redundant switches were operating properly. There have been no previous similar occurrences.
