0 3 | of drywell hydrogen and oxygen monitoring instrumentation, PT-55.4PC, drywell
0 4 | hydrogen analyzer, 2-CAC-AT-1263-1, indicated properly in response to an applied test
0 5 | signal but failed to actuate the "Containment Atmospheric Oxygen-Hydrogen High"
0 6 | annunciator as required. This event did not affect the health and safety of the
0 7 | public.

1 0 A bad solder joint in the 1263-1 alarm actuation potentiometer circuitry, attributed

1 1 to a manufacturing defect, prevented actuation of the annunciator. The solder joint

1 2 was re-soldered and the PT was satisfactorily completed. The 1263-1 analyzer,

1 3 Model No. 7C6A, was then returned to normal service. No further action to this

1 4 event is required.
