This refers to the routine resident safety inspection by Mr. J. Thomas on January 3 - March 1, 1982 at the Oyster Creek Nuclear Generating Station, Forked River, New Jersey. The inspection consisted of document reviews, interviews, and observation of activities. The findings were discussed with you and Mr. J. Carroll of your staff.

Apparent violations of NRC requirements are cited in Appendices A and B and categorized under the NRC Enforcement Policy, 10 CFR 2 Appendix C (47 FR 9987, March 9, 1982). A reply is required and should be prepared in accordance with Appendices A and B. It is exempt from the Office of Management and Budget's clearance procedures under the Paperwork Reduction Act of 1980, PL 96-511.
