This letter provides our response to NRC Violation 416/82-18-01 as transmitted by your letter dated March 23, 1982.

I. ADMISSION OR DENIAL OF ALLEGED VIOLATION

Mississippi Power & Light Company admits to the subject violation as stated.

II. THE REASON FOR VIOLATION IF ADMITTED

There was a failure to denote clearly signature authority in administrative level procedures.

III. THE CORRECTIVE STEPS WHICH HAVE BEEN TAKEN AND THE RESULTS ACHIEVED

Administrative procedure 01-S-02-2, Rev. 8, was issued on April 12, 1982. This procedure states in Section 6.2.8.a.4 that "Administrative and Section level procedures may be signed in a maximum of two locations by the Assistant Plant Manager, Nuclear Support Manager, or Plant Manager, exclusive of PSRC signature."

Administrative Procedure 01-S-01-1, Rev. 7, issued April 21, 1982, states in paragraph 6.2.3 that "Both the Assistant Plant Manager and Nuclear Support Manager have full signature authority for the Plant Manager and each other in all areas to which the Plant Manager has responsibility."

Since the above changes have been made to clearly state signature authority and management philosophy, no changes to the procedures denoted in the finding are planned.


IV. THE CORRECTIVE STEPS WHICH WILL BE TAKEN TO AVOID FURTHER VIOLATION




