Dear Mr. Takahashi:

I am trying to obtain definitive information regarding radiological content of the water in water wells in Los Angeles. Joseph Daly in your office advised that I direct my questions to you. My specific questions are as follows:

A. Standards

- 1. What agency or agencies are responsible for determining the frequency and nature of radiologic monitoring of the water in water wells?
- 2. What agency or agencies are responsible for setting legal standards for radiological content of the water in water wells?
- 3. Who (specific city, state, or federal agency, or individual well owner or well operator) must do the monitoring?
- 4. For which radionuclides must monitoring be done?
- 5. What levels of these nuclides are permitted under current standards?

B. Monitoring and Results

What radiologic monitoring has been done to this date since 1950 of the following wells: what are the results of this monitoring? (The wells are located in Geologic Area 16, U-05 A3 15/15W. I identified the wells using a map available at the Department of Water Resources, 849 South Broadway, phone 620-4148. I have enclosed a copy of the map for your use.)
