The attached submittal contains the first of two reports describing the steady state thermal-hydraulic analysis in use at Westinghouse for boiling water reactor cores. A second report, to be submitted at a later date, will describe the critical power correlation and methodology. The submittal provides suitable benchmarking both with analytical solutions and with measurements from plant data. This submittal is in advance of the scheduled commitment presented in the above reference. Westinghouse requests a timely review of the supplied information and approval of the attached document.


