In accordance with 10CFR50.30(c)(1)(i), South Carolina Electric and Gas Company, acting for itself and as agent for South Carolina Public Service Authority, herewith files sixty-three (63) sets of amendment No. 33 of the Final Safety Analysis Report (FSAR) for the Virgil C. Summer Nuclear Station. The material submitted contains three (3) signed originals and sixty (60) conformed copies thereof.

This amendment includes a general update of many plant layout drawings and system flow diagrams which have been revised to reflect plant as-built conditions. These changes are minor in nature and do not require any changes to the material sections of the FSAR. Also included are several typographical corrections, table updates and page changes which were described in previous letters to the NRC.

A certificate showing compliance with 10CFR2.101(a) concerning distribution to other federal, state and local officials is attached.




