The purpose of this modification is to: (1) increase the contract ceiling amount by \$180,000.00 from \$518,350.09 to \$689,350.09, and (2) revise the G&A rate for subcontracts & ODC. Accordingly, the contract is hereby modified as follows:

1. Under Section B.2, Consideration and Obligation--Task Orders, the first sentence in paragraph a. is deleted in its entirety and the following sentence is substituted in lieu thereof:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$691,394.00."

2. Under Section G.1, Indirect Rates (MAR 1987), the G&A rate for subcontracts and ODC shall be revised to read as follows:

All other terms and conditions of the subject contract remain unchanged.
