The purpose of this modification is to extend the contract period of performance to July 31, 1990; provided funding of \$10,000; and to increase contract ceiling by \$10,000.

Accordingly the contract is modified as follows:

1. Under Section B.2, Consideration and Obligation -- Task Orders (MAR 1987), Subparagraph a., the first sentence is deleted in its entirety and the following is substituted in lieu thereof:

"a. The total estimated amount of this contract (ceiling) for the products/services ordered, delivered and accepted under this contract is \$208,700.28."

2. Under Section B.2, Consideration and Obligation -- Task Orders (MAR 1987), Subparagraph b., the first sentence is deleted in its entirety and the following is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$208,700.28."

3. Under Section F.6, Duration of Contract Period (MAR 1987), the first sentence is deleted in its entirety and the following is substituted in lieu thereof:

"The ordering period for this contract shall commence on 4/15/88 and will expire on ~~7/31/90~~." *aliskio*

All other terms and conditions of this contract remain unchanged.
