However, the inspection disclosed that you had not yet revised your Emergency Plan and its implementing procedures to address the concerns identified by the December 1992 Reactor Safety Committee audit (see Paragraph 4 of the enclosed report). We encourage you to provide a level of management attention sufficient to achieve timely resolution of these audit concerns.
