SUBJECT: CONFIRMATION OF ACTION LETTER

This is to confirm the conversation between Mr. Frederick Frongillo, Jr., and Mr. Charles L. Cain of my staff on October 10, 1990. Based on this conversation, it is my understanding that Western Stress, Inc., will take the following action:

Mr. Roland Dellarciprete will be prohibited from engaging in licensed activities pending NRC review of the event in which this radiographer received whole body and extremity radiation exposures in excess of regulatory limits.

These actions are necessary as result of the licensee's report to NRC on October 5, 1990, in regard to the event that resulted in the overexposure to the radiographer during work at a facility in Bordentown, New Jersey, on the same date. This event is under review on site by NRC personnel dispatched from our Region I office, King of Prussia, Pennsylvania.

Issuance of this Confirmation of Action Letter does not preclude the issuance or an order formalizing the above commitments or requiring other actions. Nor does it preclude NRC from taking enforcement action for violations of NRC requirements that may have prompted the issuance of this letter.
