Dear Mr. Sholly:

This is in further response to your letter dated May 17, 1982, in which you requested, pursuant to the Freedom of Information Act, that ten categories of documents, as described in your letter, be placed in the NRC Public Document Room (NRC PDR) located at 1717 H Street, N.W., Washington, D.C.

In further response to your request, document (a) A Note, undated, to B. Grimes from H. J. McGurren, Subject: Preservation of Documents Concerning the Indian Point Emergency Planning Exercise Held On March 3, 1982, (1 page), is released in its entirety, and document (b) A Memorandum dated February 25, 1981 to M. Chopko, from J. A. Martin, Jr., Subject: Comments On Your Brief, Re: 15 Minute Warning (4 pages), contains information which constitutes a legal work product, and it is being withheld from public disclosure pursuant to Exemption (5) of the Freedom of Information Act (5 U.S.C. 552(b)(5)) and 10 CFR 9.5(a)(5).

Pursuant to 10 CFR 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for this denial is Mr. Leonard Bickwit, General Counsel of the Commission.

This denial may be appealed to the Commission within 30 days from the receipt of this letter. Any such appeal must be in writing, addressed to the Secretary of the Commission, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

Further, we offer the following comments on specific lettered paragraphs contained in your request:

- A. See, at least, documents A-9 and A-16, as well as NUREG/ CR-1856, Volumes 1 and 2 on file in the NRC PDR.
- B. See, at least, Appendix A documents A-2 and A-63, as well as NUREG/CR-1856 on file in the NRC PDR.

- C. See, at least, Appendix A document A-19, as well as Section 6.3 of the FSAR on file in the NRC PDR. Meteorological data for the Indian Point Site is contained on magnetic tape used for CRAC analysis provided by the licensee's contractors. These data can be made available for inspection by appointment only by telephoning Mr. Frank W. Karas at (301)492-8133.
- D. See, at least, Appendix A document A-1, A-3, A-17, A-68, A-78, as well as the Emergency Plans, and the Indian Point Probabilistic Safety Study which are on file in the NRC PDR.
- E. See, at least, Appendix A documents A-14, A-15, A-73, A-75, A-76, and A-77, as well as the Emergency Plan, and NUREG-610, NUREG-654, and NUREG-818 on file in the NRC PDR.
- F. No specific comments to offer.
- G. This published document, Meteorology and Atomic Energy (1968) by Slade, TID-24190, may be obtained from the National Technical Information Service, Springfield, Virginia 22161 at its published price.
- H. See, at least, Appendix A documents A-26, A-33, A-43, and A-79 on file in the NRC PDR.
- This information is available from the PDR and LPDR under Emergency Preparedness.
- J. Concerning computer-printouts of CRAC runs for Indian Point Units 2 & 3, a voluminious output of several feet thick can be made available for inspection by appointment only by telephoning Mr. Frank W. Karas at (301)492-8133.

Concerning microfiche of CRAC runs completed or aborted, the NRC's records are not yet sorted or identified, and they can be made available for inspection by appointment only by telephoning Mr. Frank W. Karas at (301)492-8133.

Other documents which fall within the scope of your request relate to the TMI Re-start proceeding, and Diablo Canyon. For the Re-start proceeding, all documents are either already in your hands or are in the NRC PDR. A listing of those documents is enclosed as Appendix B.

Pursuant to the Freedom of Information Act (FOIA), please place copies of the following documents in the NRC's Public Document Room at 1717 H Street, Washington, D.C.:

- A. All documents related to evacuation time estimate studies prepared by Parsons, Brinckerhoff, Quade & Douglas or CONSAD Research Corporation. Such documents include, but are not necessarily limited to, the original evacuation time estimate studies themselves, evaluations of the studies by the NRC, by NRC contractors, or by any other person or entity, comments on the evacuation time estimates by any person or entity, and calculations or studies performed to confirm the accuracy of the results of the original evacuation time estimates, whether these calculations or studies were performed by NRC, its consultants, or other persons or entities.
- B. All documents discussing or related to an analysis of evacuation time estimates for the Indian Point Nuclear Plant Emergency Planning Zone using the CLEAR code or any other form of analysis, and any comments on that evaluation or analysis.
- C. All documents providing meteorological information related to the Indian Point Nuclear Plant, including wind roses, wind direction and persistence data, precipitation frequency and persistence data, precipitation amount data, and dominant wind trajectories.
- D. All documents discussing the use of evacuation time estimate studies for any purpose by either the NRC, utilities, and/or local and state emergency planning personnel.
- E. All documents discussing the establishment and/or use of Emergency Action Level (EAL) criteria at nuclear power plants, including regulatory criteria, evaluation criteria, standard lists of events to

be considered in establishing EALs, and evaluations of the adequacy of EALs for any nuclear power plant.

- F. All documents discussing or evaluating work, publications, testimony, or other presentations on emergency planning by Dr. Donald Ziegler, Dr. Stanley Brunn, Dr. James Johnson, Dr. Jan Beyea, or Dr. Frank von Hippel.
- G. A copy of Meteorology and Atomic Energy by Slade, as well as any draft or final version(s) of any update or revision to this document, including comments on such draft or final version(s).
- H. All documents discussing the use of ad hoc respiratory protection during radiological emergencies, including copies of any contracts to evaluate such respiratory protection and any documents generated as a result of such contracts.
- I. All correspondence to or from or routed to or from NRC personnel in Region I to NRC headquarters, or from NRC personnel in Region I to FEMA, or from NRC personnel in NRC headquarters to FEMA, or from FEMA to NRC personnel in either Region I or headquaters, which discusses in any way emergency planning at Indian Point. Such correspondence includes any documents related to the plans of Consolidated Edison Company, PASNY, the counties of Rockland, Putnam, Westchester, and Orange, and the State of New York or any of its agencies.
