MOTION BY INTERVENOR FOR A 30 DAY EXTENSION OF THE DISCOVERY PERIOD

Pursuant to 10 CFR 2.711 CREC hereby requests a 30 day extension of the discovery period.. The Intervenor feels that said extension is reasonable and would better facilitate the fair and orderly disposition of the proceeding for the following reasons:

1. Information required by the intervenor for the proper formulation of questions for interrogatories and answers to interrogatories has not been forthcoming. In short, no additional analysis of the SFP expansion has been recieved.

2. Intervenor's reliance on voluntary assistance, advice, and research, as well as recruitment of voluntary expert testimony produce limitations and problems that are so time consuming as to make the November 1 deadline burdensome and unreasonable.

3. Furthermore, the Intervenors are further impeded in their participation because of their agricultural orientation,

and their corresponding involvement with the Fall harvest. 78/0200134G



Intervenor also contends that because LACEWR's Cycle 5 seems-likely to be a lengthened fuel cycle, because of several months of reduced operating power, numerous scrams and extended shutdowns, and a proposed four week shutdown, commencing October 14th, a 30 day extension in this phase of the proceeding would not delay the comencement of Cycle 6.

Therefore, because of the aforementioned reasons, the Intervenor believes that an extension of the discovery period would be in the best of all parties concerned, and more importantly, better serve the interest of justice.
