CRGR MEETING NO. 193

The Committee to Review Generic Requirements (CRGR) will meet in the afternoon of Wednesday, October 24, 1990, in Room 2 F-17, OWFN. The agenda is as follows:

1:00-2:00 p.m.

L. Shao (RES) will present a final rule amending 10 CFR 50.61 on pressurized thermal shock. (The review package is #32 distributed to CRGR members on October 12, 1990).

2:00-4:30 p.m.

R. Bosnak (RES) will present a proposed rule (for comment) amending 10 CFR 50.55a to endorse newer editions of the ASME code. (The review package is #31 distributed to members on October 12, 1990).

4:30-4:45 p.m.

The Committee will discuss a member comment on the proposed revisions to the CRGR Charter. (The issue was described in a note from D. Allison to members dated 10/4/90.)

If a CRGR member cannot attend the meeting, it is his responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the presentation, and (4) assuring the agenda modifications are coordinated with the CRGR contact (J. Conran x29855) and others involved with the presentation. Division Directors or higher management should attend meetings addressing agenda items under their purview.
