Gentlemen:

Pursuant to Title 10, Code of Federal Regulations, Part 40, Source  
 Material License SUA-1326 is hereby amended to revise License Condition  
 No. 26 to read as follows:

26. The licensee shall provide for the reclamation and decommissioning of the Ore Buying Station site as described in the licensee's submittal "Decommissioning and Reclamation Plan, Blanding Ore Buying Station," submitted by letter dated June 25, 1981, subject to the following modifications:
  - A. Any facilities, structures or equipment which are not decontaminated to below the guidelines set forth in Annex C to this license, "Guidelines for Decontamination of Facilities and Equipment Prior to Release for Unrestricted Use or Termination of Licenses for Byproduct, Source or Special Nuclear Material," dated November 1976, shall be disposed of offsite at a licensed radioactive waste disposal facility or uranium mill tailings disposal facility.
  - B. Any soil contaminated to levels above the standards in the "Final Generic Environmental Impact Statement on Uranium Milling," NUREG-0706, Volume II, Appendix J, dated September 1980, shall be disposed of offsite at a licensed radioactive waste disposal facility or uranium mill tailings disposal facility.
  - C. During at least the two complete growing seasons following initial seeding, the licensee will inspect, and where revegetation is not successful, reseed and re-treat these areas as necessary to induce complete vegetation cover prior to the removal of the fence surrounding the Ore Buying Station.

D. The licensee shall at all times maintain NRC-approved financial surety arrangements covering the costs for decommissioning and site reclamation of the Blanding Ore Buying Station. Surety arrangements covering these costs shall be provided until April 13, 1984 by Letter of Credit No. 45345 dated April 13, 1982, issued by the National Bank of Detroit.

At least ninety days prior to the expiration date of existing Letter of Credit No. 45345, or of any subsequent sureties, or any revision to existing surety arrangements, the licensee shall submit a copy of the proposed new surety or revision to the U.S. Nuclear Regulatory Commission, Washington, D.C. 20555. This submittal shall account fully for revised costs for inflation and for implementing modifications A, B, and C of this Condition and shall provide supporting documentation showing a breakdown of the site reclamation and decommissioning costs, as well as the basis for determining these revised costs.

The NRC will not terminate this license until final reclamation satisfies all applicable NRC regulations.

All other conditions of this license shall remain the same.

The principal effect of this amendment is to approve the financial surety arrangements provided by Letter of Credit No. 45345 issued by the National Bank of Detroit, which provides for costs of the operations described in PRL's "Reclamation and Decommissioning Plan" submitted by letter dated June 25, 1981.

The revisions to Source Material License SUA-1326 effected by this amendment have previously been discussed with and agreed to by Messrs. U.K. Gupta and F.W. Gerdeman of PRL.
