12 DESCRIPTION OF AMENDMENT/MODIFICATION


WHEREAS, the Government and the Contractor mutually agreed to incorporate revised loaded hour rates into the contract, based upon the Contractor's established accounting practices; and

NOW, THEREFORE, Article III entitled "Consideration," is hereby modified by changing the loaded hourly rate of the Senior Hydrogeologist from "\$66.62" to "\$72.74" and by changing the loaded hourly rate for clerical support from "\$17.12" to "\$18.71."
