The period of performance is hereby being extended to allow Gage-Babcock sufficient time to complete the contract's required efforts. The below changes to the contract are made at no additional cost to the Government.			
1) In Article II - Period of Performance - delete the date "30 March 1982," and substitute the date "30 September 1982" in lieu thereof.			
2) Article VII - Estimated Cost and Obligation, paragraph no. three (3) - delete the date "March 15, 1982," and substitute the date "September 30, 1982" in lieu thereof.			
Except as provided herein, all terms and conditions of the document referenced in Block 8, as heretofore changed, remain unchanged and in full force and effect.
