The Nuclear Regulatory Commission has approved an amendment to the Agreement with the State of Illinois under which the State will assume regulatory authority over uranium and thorium mills and mill tailings. The amended agreement will become effective on November 1, 1990. The Illinois Department of Nuclear Safety will be the State agency responsible for administering the regulatory program.
