## MEMORANDUM AND ORDER (Terminating Proceeding)

This proceeding began when Staff issued an Order Imposing Civil Monetary Penalty on Cambridge Medical Technology Corporation (CMT) on account of an alleged violation of NRC requirements. See 55 Fed. Reg. 22419, June 1, 1990. CMT responded to this Order by requesting a hearing. In light of the fact that CMT's response raised matters concerning CMT's financial condition of which Staff had been unaware, we held the proceeding in abeyance at Staff's request in order to permit further discussions between Staff and CMT.

Staff then submitted for our approval a second Order which rescinds the original Order. The second Order continues to allege a violation of Commission requirements,

but notes that CMT's actions in connection with the orderly termination of its license and decontamination of the facility provide reasonable assurance that the violation will not recur. The second Order does not impose a civil penalty because to do so potentially would jeopardize the decommissioning of the facility. Simultaneously, Staff moved to terminate the proceeding.

On August 30, CMT responded to Staff's second Order and motion, stating:

We do not object to this motion for termination as long as such non-objection does not in any way represent an admission or acceptance on our part that the NRC's findings were correct.

Because we were unsure whether this response was intended to invoke CMT's right to a hearing, in a Memorandum and Order of September 14 we approved Staff's second Order and granted its motion to terminate the proceeding, provided that CMT was given five days in which to request a hearing on the second Order and therefore on Staff's allegation. Following a telephone call from CMT which indicated some uncertainty, on September 19 we held a conference call in which Mr.

Joseph P. Carroll, Chairman, President, and CEO of CMT, Ms. Colleen P. Woodhead, Counsel for NRC Staff, and the Board's Chairman participated.

The purpose of the call was to discuss the status of this proceeding and to determine whether CMT wished a hearing. In the course of that conference call, CMT and

Staff appeared to agree that the proceeding should be terminated as it presently stands. A Memorandum and Order terminating the proceeding was prepared which purported to set forth the agreement between CMT and Staff. Because the Memorandum and Order set forth their agreement, on September 19 it was circulated to Staff and CMT in advance of issuance for their acceptance. Specifically, the Memorandum and Order was mailed to Joseph P. Carroll, Chairman, President, and CEO of CMT for signature and transmittal to Staff counsel for her signature. Following signature by CMT and Staff, it was to be entered by the Board.

One month has passed and no response has been received from CMT. Consequently, we hereby approve Staff's second Order and grant its motion to terminate this proceeding.

It is so ORDERED.
